



## Compliance is suite for SUEZ

### Summary

Major waste and recycling group SUEZ recycling and recovery UK has seen its use of Vision develop from analogue tachograph analysis to a comprehensive compliance suite encompassing digital tachographs, driver licence checks, Vehicle Inspection Services (VIS), Training and Driver CPC monitoring and PCN management. The platform manages over 1,300 vehicles and 1,500 drivers across 50 main depots and 100 operating centres each performing hundreds of stops and deliveries every day.

### The Challenge

As SUEZ was growing rapidly in the mid-2000s, it was manually analysing hundreds of tachographs each week and began working with Vision to analyse analogue tachographs as its existing provider could not manage the volume of analysis required. It also needed a solution for managing a rapidly growing fleet and number of drivers while providing the board with the visibility and reassurance of the organisation's compliance.

### The Solution

SUEZ' use of Vision has mirrored the platform's development and after originally mailing analogue tachographs for analysis, SUEZ moved to using scanners and now uploads digital tachograph data direct to the Vision platform. In addition to digital tachograph analysis, also uses the platform for driver licence checks, Vehicle Inspection Services (VIS), Training and Driver CPC and PCN Management.

## Real World Impact

Vision increases visibility and provides a real time snapshot of compliance across the organisation. Previously, SUEZ would see monthly infringements reports, but now infringements are monitored continuously helping SUEZ focus on the areas and sites where additional training or remedial action is required. When onboarding new businesses or contracts, the platform provides consistency and ensures all parts of its business are compliant and meeting the company's stringent standards.

Reports are easy to generate and increase visibility across the whole organisation, providing board level reassurance that the organisation is operating in a legal and compliant way. Vision provides clear, timestamped data that helps SUEZ demonstrate compliance with DVSA regulations. By ensuring that all maintenance and mileage records are accurately accounted for, it reduces the risk of discrepancies and regulatory issues. Maintaining a satisfactory Operator Compliance Risk Score (OCRS) is crucial for SUEZ and Vision helps it keep all compliance records up to date.

Vision also supports compliance at an operational level through inbuilt alerts to inform managers of any areas that need addressing such as missing mileage or incomplete training. Debrief status is also clearly visible so managers can ensure necessary remedial action is taken and micro training debrief videos provide consistency across the organisation.

SUEZ operates a high number of double-manned vehicles with high-frequency stop/start collections, and Vision enables it to accurately track the second driver's working time and prevents misclassification of periods of availability (POA). Vision also identifies where overnight rest has not been recorded allowing relevant drivers to be trained so that all rest periods are documented and compliant.

Vision also tracks driver CPC training, enabling managers to see the training required for its drivers to remain compliant with DCPC requirements. SUEZ also uses Vision for PCN management and, through a combination of "hot spot" identification, changing driver behaviour and prompt payment, has reduced fines and made significant savings.

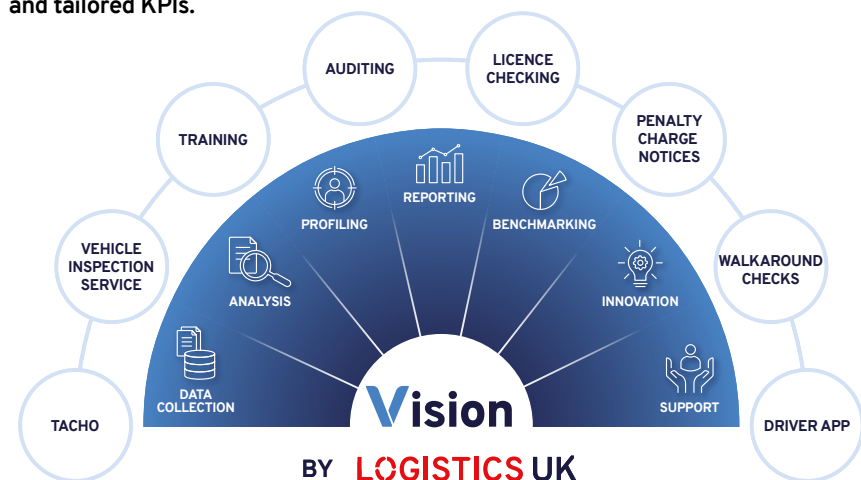

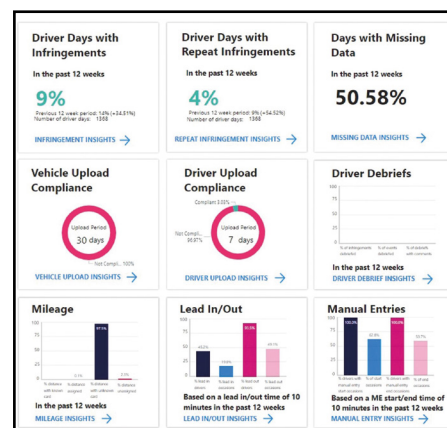
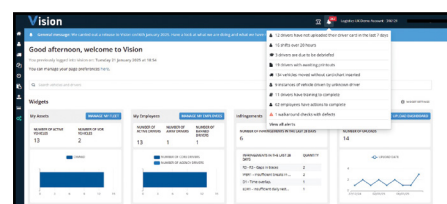
