Welcome

Vans are growing in importance, and have been for some time. According to recent research commissioned by Logistics UK, van travel has more than doubled in the last 25 years, and now accounts for almost one in six miles travelled by all motor vehicles.

Since the COVID-19 pandemic swept the UK two years ago, that pace of growth has accelerated. A decline in 'bricks and mortar' retail has seen a corresponding boom in online shopping, which has required an ever-growing army of couriers to deliver the goods we order to our doorsteps. I believe this is a trend that will not be reversed.

There were 4.6 million vans on Britain's roads in 2020, an increase of 29% on 2010, according to the latest figures from the Society of Motor Manufacturers and Traders (SMMT), leading some commentators to describe this as 'the decade of the van'. To put that in context, vans now account for more than one in nine motor vehicles on Britain's roads.

As their numbers continue to rise, so too do the responsibilities of van operators to ensure that their fleets adhere to the highest standards of safety and compliance.

Our recent survey shows that van operators' top three priorities are maintaining vehicles, compliance and fleet risk management, and the procurement of vehicles that are more environmentally friendly. As one of Britain's biggest business groups, Logistics UK is uniquely well placed to help operators with all three of these issues. We offer a broad range of high-quality services and products to help managers of vans ensure their fleets remain safe, legal and compliant.

With the end of the sale of petrol and diesel vans less than eight years away, decarbonisation is going to present the industry with some profound challenges. In this supplement, we look at what the options are and the next steps operators can take in their journey to net zero.

Edmund King OBE, President of the AA

Since being appointed as President of the Automobile Association in 2008, Edmund King has become a well-known spokesperson for British motorists. A reassuringly familiar presence in the news media, he campaigns and comments on everything from potholes to fuel prices, and speed limits to car tax.

FROM A CAR-FILLED CHILDHOOD...

King's career in automotive spans more than 30 years, with senior roles at the British Road Federation, the RAC and the AA, but he can trace his interest in motor vehicles back to his Norfolk childhood, where the boy next door happened to be the son of one Colin Chapman, the founder of Lotus Cars.

His neighbour's driveway was frequently lined with Lotus Elans and Lotus Europas, and Chapman even flew the young King to his first Grand Prix at Silverstone at the age of seven, where he met some of the racing drivers of the day. Added to which, his father also owned a range of "odd cars", such as a range of Citroen DS cars from the 70s and 80s.

"It was a combination of those things that meant from an early age I just had this interest in cars and automotive," King said.

An interest in the political system, however, led him to study politics at university in the 1970s and he later worked in radio in Los Angeles.

"My job at the AA combines automotive, broader politics and media. It's quite seriously the ideal job for me – I can't really think of any other sector I prefer," he said.

... TO A CAREER IN AUTOMOTIVE

King got his professional start in the automotive sector with the now defunct British Road Federation (BRF) in the 1990s, where he worked as a Campaigns Manager. The BRF represented companies and trade associations, including Logistics UK (then FTA), SMMT, the RAC and the AA, involved in the wider automotive sector.

"One of our biggest campaigns was East Anglia Roads to Prosperity, which was all about getting the A11 dualled," King recalled, "For me, as I originally lived in Norwich, that was a perfect campaign because the chairman of our campaign was a guy called Sir Arthur South, who was Chairman of Norwich City Football Club, and I followed Norwich City Football Club from the age of five. So again, Sir Arthur inviting me to join him in the box at Carrow Road was a fantastic perk of the job."

His years at BRF got King involved in campaigning and media and working with MPs and from there he was spotted by first the RAC and later the AA.

CELEBRATING THREE DECADES OF PARTNERSHIP

King describes the logistics sector as important not just to the AA and business, but also to the UK economy as a whole.

"The work that Logistics UK and its members do really is the backbone of Britain and we've probably seen that more in the last two years," he said.

The COVID-19 pandemic and the way lifestyles have changed, with more people working and shopping from home, has given the public a more direct relationship with the logistics sector.

While the AA is probably best known as the biggest breakdown assistance company in the UK, King believes it is important that it helps essential business to function through business groups like Logistics UK and the British Chambers of Commerce.

In 1992, the AA and Logistics UK began their partnership to deliver the popular Logistics UK Recovery service. A quarter of a million incidents and 50,000 recoveries later and the partnership is still going strong.

On the longevity of the partnership between the two associations, King said: "I think the relationship and the fact that it's gone on for 30 years is probably a testament to both organisations. We're both service led, delivery led, getting things done and that certainly is something that runs through the AA. When my colleagues are dealing with Logistics UK it shows that they deal with the customer first and the vehicle second."

THE RISE OF VANS

Vans now account for more than one in nine vehicles on Britain's roads, and their growth in number can be attributed to their astonishing versatility, King maintained.

"Vans are the unsung hero, because they do everything," he said, "From the florist to the bakery to the window cleaner to the mechanic to the service delivery."

Outdated stereotypes of 'white van man' are wide of the mark, he argued, and vans should be recognised for the role they play in delivering essential services. Lockdown, he believes, has helped change the public's perception, leading to a dawning realisation from the general public, that van drivers deliver the essential services that keep Britain going.

"The van sector worked incredibly well during lockdown, they were out there day and night. If you think back to March 2020, it was a great unknown, it was dangerous being in contact with other people. People were dying of COVID, our hospitals were full and we should not underestimate the roles that Logistics UK members played during that period."

THE DRIVE TO DECARBONISE

When the government announced its ban on selling new petrol and diesel cars and vans from 2030 was King surprised by the scale of its ambition?

"I think I described it as "challenging", and it is pretty radical," he said.

An electric car driver and enthusiast, King said that they had improved significantly over the last 20 years, but believes the van sector is lagging the car sector in this respect as it started electrification earlier.

The AA was involved in an EV rally in Scotland last year, during the COP26 conference, which included some Maxus vans. It completed 1,200 miles in electric vehicles over five days.

"One of the rules was that you couldn't charge overnight," King said, "You had to charge on your journey and we proved with both vans and cars that with a bit of planning it could be done."

Rallies are one thing, however, and everyday business quite another. Although it does have some electric vans in its fleet, King concedes that there is still some way to go before the AA electrifies its patrol vehicles.

"When we look at our own fleet, particularly our patrol fleet, we need a van that can tow two tonnes, that's got quite an extensive load capacity for all the tools and currently there isn't one on the market that meets all our needs," he said.

Another issue is that the AA's 2,500 patrol men and women do not leave their vans in a depot overnight.

"You've got that broader question: can you charge at home? Have you got off street parking to get in a charging unit? Because if you live in a flat or a terraced house it can be problematic. And that will affect van drivers more than car drivers. I just think some of those issues haven't been addressed enough," King said.

The AA is now looking at where it can deploy electric vans, where it does not need the towing capacity.

"We have something called Fuel Assist which we use with your members who have put in the wrong fuel," King said, "For that service we don't need to tow the vehicles, we sort out the fuel there and then. So, within our own fleet, we are looking to identify niche areas where we can use zero emission vehicles now."

OTHER FUELS ARE AVAILABLE

While King sees electric as the most viable alternative fuel for vans, he also thinks there could well be a role for hydrogen fuel cell for bigger vans and HGVs.

"I think it will be a mix," he said, "I know government's always saying we don't pick winners, but they do point in one direction and I think one of the problems in developing infrastructure is possibly there has been an overemphasis on electric and not enough on hydrogen or even other liquefied gases, because electric does have some downsides."

One of those downsides is charging time. While it is much quicker to fill up with hydrogen, the refuelling infrastructure for hydrogen is even more patchy, with just 14 hydrogen refuelling centres currently available in the UK, five of which are within the M25.

FUELLING INFLATION

A major concern for the logistics sector at the moment is the steep rise in petrol and diesel prices, exacerbated by the geopolitical situation in Ukraine. However, King believes that the rise in fuel prices can also be attributed to an increase in demand as economies come out of lockdown.

Fuel prices have spiked despite the fact that until recently Fuel Duty had been frozen for more than a decade. Although the Fuel Duty rate is static – 52.95 pence per litre – the VAT goes up with the price.

"One of the things we've said to government, and this would help industry, is of course government can't govern the global situation but what they can govern is the tax take," King said.



The AA has campaigned for a fuel price stabiliser, so if the bulk cost of oil goes up, the VAT can be reduced, and if it goes down, the VAT can revert to 20%.

“The Treasury has looked at it before, but it never really happened in practice,” he said, “That is something they could do without losing money, because the VAT goes up as the cost goes up. So you wouldn’t necessarily lose money for the government.”

THE ROAD AHEAD

There are now a record 4.6 million vans on Britain’s roads, according to the latest figures from SMMT. How does King see their role evolving over the coming decade?

“I actually think those numbers will increase, because we are becoming more reliant on services, not just at home but to our offices as well,” he said.

As industry increasingly relies on buying services in, rather than hosting them in house, those services need to be brought in on wheels because they often involve carrying heavy tools or goods.

“I actually think that the outlook for the sector is very bright despite the challenges,” King said, “There are many challenges, zero emissions being one of them.”

The driver shortage, particularly at the upper end, is another challenge. The AA is not immune to these skills shortages as its recovery vehicles need to be driven by drivers with HGV

licences. To address the issue it has started its own driver academy, to encourage young people to learn to drive HGVs.

“Like everyone else we’re suffering,” King said, “So I think there will be more in-house training, more apprentices, more academies which I think is a good thing because it helps bring in a more diverse population. We’ve got three females on this latest intake for our driver academy, whereas if we just went out to try to poach HGV drivers from elsewhere, we wouldn’t have got three females so there can be benefits of doing more in house for bigger companies with bigger fleets.” ■



Van miles have more than doubled in the last 25 years, research reveals

Van ownership and travel has grown substantially, according to research recently commissioned by Logistics UK. Citing statistics from the Department for Transport and Society of Motor Manufacturers and Traders, the research reported that there has been a 106% increase in van travel over the past 25 years, with vans accounting for 16% of all motor vehicle miles in 2019.

The research, which was undertaken by research agency Red Brick, consisted of an online survey and in-depth telephone interviews with 24 participants. When asked about their top van priorities, more than seven out of ten respondents placed vehicle maintenance (74%) and compliance and fleet risk management (71%) at the top of their agendas. Interestingly, procurement of more environmentally friendly vehicles was placed third (56%) closely followed by the procurement of new vehicles.

On maintaining vehicles, respondents reported that the importance of day-to-day maintenance was connected to both the difficulty of obtaining new vehicles and driver training – ensuring that drivers know what needs to be monitored during their daily walkaround checks.

“We need drivers to be able to maintain their vehicles,” one respondent said, “drivers who aren’t fully educated on maximum load weights could damage the vehicles.”

On compliance and fleet risk management, the challenges concerned enforcing defect reporting, especially for employees for whom driving is seen as a secondary aspect to the job.

For more than half of respondents (56%), procuring greener vehicles was a top priority. While the number of Ultra Low Emission Vehicles was increasing, a 2019 Department for Transport report found that 96% of vans were powered by diesel.

Lack of viable options in the marketplace was cited as a major barrier to the adoption of electric vehicles: “We’re looking at electric vans, but there’s just not enough out there at the moment,” one respondent remarked.

Denise Beedell, Public Policy Manager, Logistics UK, said: “This latest research shines a revealing spotlight on the issues that are of prime importance to managers of van fleets. Happily, vehicle maintenance, compliance and decarbonisation are all areas where Logistics UK can support van operators.”

60 second interview

Tim Campbell has enjoyed a 40-year career dedicated to commercial vehicles. He was the founder of Campbells Commercial Vehicle Marketing Group, the largest of its kind in Europe, which he sold in 2014. He is an international guest speaker at industry events, including the Tokyo Motor Show in Japan, CV Middle East in the United Arab Emirates and the NTEA Conference in the USA. He is currently Managing Director of Campbells Consultancy, helping commercial vehicle fleets make the transition from diesel to zero emission vehicles.

How did you get your start in the automotive sector?

To cut a very long story short, I started at ERF Trucks as a student research and development engineer which was an absolutely brilliant time with great work colleagues who gave me a lot of stick as I was a friend of the Managing Director's daughter! I am sure you can imagine the comments and leg pulling I got but I loved every minute and some are still friends to this day. I then worked for Gardner diesel engines as a Sales Engineer and from there to Mercedes-Benz UK and Leyland Trucks on fleet sales and then contract hire/rental director with one of the van and truck rental companies.

What has been the single biggest change to the industry you have witnessed during your career?

It probably won't come as any surprise if I said the one we are going through now. Our industry is trying to do in 120 months what has taken 120 years to achieve with diesel. By that I mean, diesel has been with us for over a hundred years and yet in less than eight years from now we will be banning the sale of new diesel vans and then, new trucks up to 26 tonnes GVW in 13 years (average 10 years). This is a mindset change over virtually every aspect of our industry from manufacturers, bodybuilders, fuel suppliers and, of course, the poor van operator who is in the middle of all this upheaval still trying to make sense of it all! Infrastructure, myth busting and driver training are keys to its success but I'd need more than one page to explain these in more detail.

Why and when did you set up your first business?

Wow – I can't remember that far back but most people in the industry probably remember my major company Campbell Automotive which I started in 1997 which covered training, data, consultancy and recruitment in the van and truck industry, mainly working with commercial vehicle manufacturers. Indeed, I still bump into friends I have trained and thankfully they are still happy to see me, well almost all of them! It was an important statement for me, because I was sick of turning up to training courses or asking for datasets and dealing with 'car people' who didn't understand our industry, so I thought I'll start one and we will just do vans and trucks and no cars! The company was based in Leyland which meant it was easy to

have staff acquainted with the commercial vehicle industry (I was born in Leyland) and it built up a good reputation I think, but that's not for me to say. It was taken over in 2013 by the DVV Media and this allowed me to concentrate on consultancy and training, travelling around the world to look at the future for commercial vehicles in the US, China, India and Australia.

In your experience what is it that prevents operators from taking their first steps to decarbonising their van fleets?


First of all I think we should differentiate between the SME market and the large fleet players such as the supermarkets and parcel couriers. I feel the van users with one or two vans

look at the upfront cost and, of course, the cost of a battery electric van is considerably higher than a diesel so there's an immediate barrier. That's even with the 'Plug-in-Grant' and the industry as a whole has little confidence in this grant, especially after the way it handled the reduction last year. So upfront cost is one factor but it has to be remembered the running costs on an electric van can be significantly cheaper, with lower maintenance and running costs. However, this needs explaining better to the buyer. We also have range as a perceived issue, I say perceived because we have to accept right now not everyone is suited to buying an electric van, it just doesn't work for some operations. To generalise, the sweet spot for an SME is someone running a van around a 50-60 mile radius in an urban environment with a driveway and 7kW, home charger, who leases or finances over a three to five year period. Once outside these parameters we may start to compromise and get to the extreme of a busy 3.5 tonne fridge conversion doing 200 miles carrying a one tonne payload in winter using the motorway like you would drive a diesel – that's a no! But there are lots in between and eventually we will satisfy that extreme operation as well. I often say it's not about range anxiety but charger anxiety. If you have planned your route and expect to stop for a 'top-up' there's nothing more frustrating than finding out the charger is out of service, and yes I know, apps like ZapMap are there but they are not 100% accurate as those that regularly drive electric vans will tell you.

The sale of new petrol and diesel vans is to be phased out from 2030. Were you surprised that the deadline was brought forward by ten years and do you think it is too ambitious or not ambitious enough?

No I wasn't surprised. I have been involved in various consultative bodies which have contributed to the decision-making process and it appears obvious to me that post-Brexit, the government has decided we should be ahead of the rest of Europe on nearly every phase out, from cars to trucks. It may be viewed now as ambitious in light of the semiconductor shortage and COVID, which has put the whole industry back at least eighteen months, particularly in the van sector, but that couldn't be envisaged when the announcement was made. We are a small island, we have the potential to move forward in many areas of electrification and hydrogen supply but it comes back to infrastructure.

What do you see as the most viable alternative fuel to diesel for the van sector?

As I said earlier, battery electric is the most obvious choice. I am not a fan of hybrids as they are just a transitioning solution. We are seeing more and more electric vans enter the market with longer ranges, acceptable payloads and they can tow. We should also remember we have conversions such as box vans, dropsides, fridges etc and these potentially have different power demands and driving characteristics. Ultimately infrastructure is key to both the needs of the SME and fleets but fleets running, for instance, 50 electric vans at one site will need to really look at the suitability of their premises, understand about charging, load balancing, cloud based communication and how to drive the van properly, which isn't as straightforward as a diesel but not hard to learn.

What role does hydrogen have to play in decarbonising van fleets?

I know PSA Group is working on hydrogen fuel cell vans and this could fill a niche demand, certainly in the near future, again due to infrastructure issues. Yes, we have recently had a hydrogen station placed in a supermarket car park but I really do believe heavy trucks should be the main beneficiary of a hydrogen economy. I have many friends in the hydrogen space, from the traditional truck manufacturers to the disruptors such as Hyzon and Tevva. Incidentally, recently I was in Germany, thanks to Mercedes-Benz, and had the opportunity to have a go in their hydrogen tractor unit GenH2 on the test. I also drove the Hyzon tractor unit whilst on a trip to Holland so they are here and working but don't let me kid you – they are still trial trucks.

The pandemic has witnessed the rapid growth of home delivery services as more people do more of their shopping online. Do you think this is a trend that will be reversed?

I don't think the two major sectors responsible for this – supermarkets and parcel delivery – will be reversed but rather plateau to a degree, with slower growth patterns as people and society learn to live with COVID rather than preventing it and subsequently return to work, albeit in a 'hybrid' fashion. Home deliveries, and the continued entrepreneurial spirit of the British people who set up small businesses time after time, will always have a van at the heart of their product delivery strategy or they will use a courier – a win for the van every time!

Unlike HGVs, vans are not currently within scope of operator licensing. Given their growth in numbers do you think now is the time to introduce mandatory regulation for the van sector?

Wow, that discussion has been going on for years! We now have lower gross vehicle limits for van operators travelling abroad for commercial use so certainly it's a start. I do feel there is merit in some cases and types of operations but these are rather niche.

With 4.6 million vans currently on Britain's roads, how do you see their role evolving in the coming decade?

Van of all shapes and sizes will always be the go-to method of transporting goods from A to B, and certainly final-mile delivery will be dominated by vans and L category vehicles. Interestingly, with the advent of the potential of electric distribution trucks over the next few years, I see a role for those to play a big part in city centre distribution, especially at night. In conclusion, the role of the van is here to stay and long may it continue! ■
