Jonathan Walker updated members on the A66 upgrade and the Tyneside (Newcastle and Gateshead) Clean Air Zone.

# **Agenda Items**

# A1 – Road Transport (Working Time) Regulations

- 1 Members support a system that is simpler. It was agreed that it can be difficult to understand the different rules and mistakes are often made.
- 2 Retain the six hours + break rule but for those on longer shifts (see comment below).

3 – It was noted that there should be a derogation or exception for the break rule. For refuse collections, a shift may last 6.5 hours, but due to the 6 hour break rule, workers must take a break half an hour from finish instead of coming directly back to depot. It was felt it would be beneficial for employees as well as the environment to have vehicles come back under these circumstances.

Members want there to be better clarity on the rules; infringements happen due to people not being sure of the rules.

## A2 – Trailer Registration

- 1 Members were not against registration. It was agreed that there are different standards across the sector and more accountability would be beneficial.
- 2 Members were concerned about how it would be administered and the amount of time it would take up for their business/operations.
- 3 One member suggested a tag might be a better solution so trailers can be tracked and an app can be used.
- 4 Members agreed registering on a V5 would be sensible so it can be checked online and that going on the VOL would be a good idea as well.

# A3 - Decarbonisation - Transitional Technologies

- 1 Lack of infrastructure especially on the highways. New technology moves quickly and there is reticence to invest if something may become obsolete or old quickly.
- 2 Government must build the infrastructure. There need to be price caps to prevent significant price hikes. Rebates were also welcomed. The technology is not available to meet current deadlines.
- 3 One member explained how they are a smaller operator and do not have their own refuelling infrastructure for transitional fuels, but they utilise a refuelling site from another operator close to them. Opportunities for local businesses to share in this way could be a way of more businesses investing in transitional fuels.

# A4 - Transport Committee Inquiry into Strategic Road Investment in England
