Minutes of the meeting held on 08 June 2023 at Marriott County Hall

ROAD/23/11 Chair's Welcome

Apologies were received and noted.

ROAD/23/12 Meeting conduct and competition law compliance

Council was directed to the relevant page in the Policy Report.

ROAD/23/13 Minutes and matters arising

The minutes of the meeting held on 09 February were adopted. There were no matters arising.

Guest Speaker Alastair MacIntyre- VP UK Einride

The Council received a presentation from Swedish company Einride, following their recent establishment in the UK. Alastair MacIntyre explained how the operation worked, using fully electric vehicles.

There was a discussion following the presentation that covered the following subjects: cost nature versus current diesel rates; subsidies; haphazard city restrictions that hamper efficient operations.

ROAD/23/14 Secretary's Report

Members received updates on Longer semi-trailers; the proposal for the Commercial Vehicle Workshop Rating Scheme; ULEZ expansion in London; smart motorways; the review of the Guide to Maintaining Roadworthiness; the Last Mile delivery policy position.

ROAD/23/15 MOT testing for Earned Recognition (ER) Operators

Members discussed Logistics UK's position of the 'Call for Evidence', which was subsequently submitted by Phil Lloyd.

Delegated testing was given the most support from members. There were negative comments surrounding any proposal to increase the time period between tests. Members generally agreed that ER was a significant cost to operators and that DVSA should acknowledge this and offer more incentives, of which delegated testing was the most supported.

ROAD/23/16 Traffic Commissioner Function Review

Traffic Commissioner Function Review – members discussed the DfT Function Review that made a series of recommendations for change. A proposal for a working group to be set up was raised, as members voiced concerns of micro-management creeping in; of 'activist' Traffic Commissioners (TCs) working on specialisms; increasing levels of bureaucracy at Public Inquiries (PIs).

ROAD/23/17 Compliance standards for light trailers

Council endorsed the policy position paper drafted by Phil Lloyd. There was a short discussion that covered aspects of education; the removal of the B+E requirement; proof of annual maintenance; and penalties for those who cannot prove compliance.

Members received a report of the recently published Electric Vehicle Report. No

comments were made.
