INTRODUCTION

- Norman Harding opened the meeting.
- The minutes of the last meeting were approved.
- Members were reminded by the Secretary about the competition law compliance guidance.

Secretary's report

• Members discussed guidance issued following the end of the longer semi-trailer trial and gave their reaction in advance of possible DfT changes. Key message was that the trial proved safety argument and new guidance was onerous for operators.

GUEST SPEAKER - SIMON CODERY - PLACES FOR LONDON (TfL's property company)

- Places for London is TfL's property company that manages the land assets of TfL and owns more land than any other entity in London, approximately 8000 sites, with a significant number of underutilised car parks in Zones 2-6
- The presentation was an overview of the project that will look at using TfL as location for public charge points for commerical vehicles, notably vans, with 5 sites in the first tender at LHR; Canning Town; Hatton Cross; East Finchley; Park Royal.
- The plan will be a joint venture plan over 30 years, which should remove the worry about different charging companies coming to the market, and give long-term planning opportunities. Charging equipment will be considered from a 5-7 replacement cycle but the grid connections will be made permanent. This plan will be fully aligned with TfL's micro hub strategy, once the joint venture has been shown to be a success.
- There was a discussion with members following the presentation that covered aspects involving leasehold properties; fire risk with EVs; availability of sufficient energy in the local area.

GUEST SPEAKER - IAN WAINWRIGHT, CHRIS STURMAN - CILT CONSULTANTS

- Members received a presentation from the CILT on a call for evidence they are hosting on kerbside access issues, with the aim to raise this issue within the minds of decision-makers across the whole of London.
